4. This agreement does not lead to a claim of usage as per articles 1 and 2. The person photographed or filmed may obtain information about the type of image usage from DPSG national scout association at any time.

5. The person photographed or filmed transfers to the photographer all usage rights to the image material necessary as mentioned purposes in article 2.

6. For reasons of data privacy the name of the person photographed/filmed is not used in public. There is no data distribution for market and public opinion polls.

7. DPSG national scout association will not pay any fee for photos or films.

8. Amendments to the agreement require a written form. The agreement can be revoked at any time in written form addressing to DPSG national scout association. It may not be possible to delete photos/videos already published.

9. With my signature I agree to the storage of personal data resulting from making of photographic and video material. In addition, I agree that DPSG may document and file the related agreement.
